This supplement (the "Third Supplement") is supplemental to, and should be read in conjunction with, the base prospectus dated 11 June 2013 (the "Base Prospectus"), the supplements dated 28 June 2013 and 2 September 2013 (respectively the "First Supplement" and the "Second Supplement") prepared in relation to the €13,000,000,000 Euro Medium Term Note Programme (the "Programme") for the issue, from time to time, subject to compliance with all relevant laws, regulations and directives, of notes (the "Notes") by Crédit Mutuel Arkéa (the "Issuer"). Unless the context otherwise requires, terms defined in the Base Prospectus have the same meaning when used in this Third Supplement.

On 11 June 2013, the Commission de Surveillance du Secteur Financier (the "CSSF") approved the Base Prospectus as a base prospectus for the purposes of article 5.4 of Directive 2003/71/EC of 4 November 2003 as amended (the "Prospectus Directive") in its capacity as competent authority in Luxembourg under the *loi relative aux prospectus pour valeurs mobilières* dated 10 July 2005 as amended which implements the Prospectus Directive in Luxembourg (the "Luxembourg Law").

Application has been made to the CSSF for approval of this Third Supplement as a supplement to the Base Prospectus for the purposes of article 16 of the Prospectus Directive and article 13 of Luxembourg Law.

This Third Supplement has been produced for the purposes of:

- supplementing the section "DESCRIPTION OF CRÉDIT MUTUEL ARKÉA AND THE GROUP" on page 64 *et seq.* of the Base Prospectus, in creating a new sub-section 6 entitled "Recent developments" on page 66 of the Base Prospectus;
